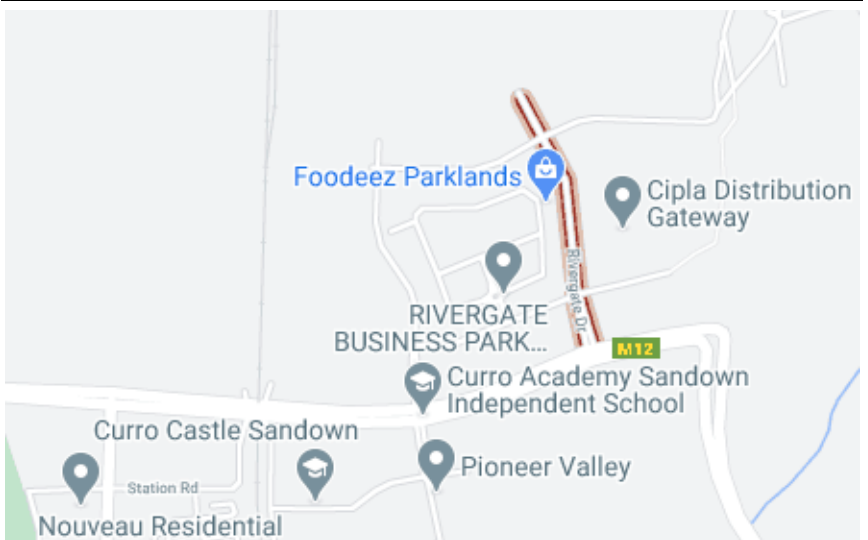

- we will hook and unhook our trailers to/from your vehicle. Please be patient when returning the trailer
- Please refrain from yourself and especially your staff to interfere in our processes (even done with good intention). Thank you.

GENERAL:

-do not overload the trailer

- Sand/Stones/Building Rubble/Instant Grass/Firewood pieces are not permitted to be loaded. DO NOT OVERLOAD THE TRAILER

-Most damages are on the Plug and Tyres/Springs/Axle and Rims : Plug repair in any case will be R300 levied. Tyre/Springs/Rims to be replaced.

- Trailer must returned in clean conditions. Must be washed if dirty. Cleaning fee will apply
- Late / after hours Return (if not agreed) on will be levied a late return fee of minimum 20% UP to 50% of the Hirefees. If returned the next morning after 7.30am a full Hire fee will apply.

1. THE TRAILER LET OUT ON HIRE ALWAYS REMAINS THE PROPERTY OF TABLEVIEW TRAILERHIRE THE HIRER WILL NOT ATTEMPT TO SELL, HIRE OR OTHERWISE PART WITH THE POSSESSION OF SAID EQUIPMENT

2. THE HIRER COMPLETELY INDEMNIFIES TABLEVIEW TRAILERHIRE IN RESPECT OF CLAIMS BY ANY PERSON. WHATSOEVER FOR THE DEATH OR INJURY OF THE HIRER OR ANY OTHER PERSON. AND/OR DAMAGE TO HIS OWN OR ANY OTHERS PERSONS PROPERTY CAUSE BY OR IN CONNECTION THEREWITH WHETHER ARISING UNDER THE STATUE OR COMMON LAW. THE HIRER UNDERTAKES TO UPHOLD STANDARD SAFETY PRECAUTIONS, IF ANY, IN RESPECT OF THE HIRER. THE HIRER IS RESPONSIBLE FOR THE INSURANCE OF HIS LAD/TRAILER.

3. THE LESSOR WILL NOT BE LIABLE FOR ANY DAMAGE TO THE LOAD. THE HIRER WILL BE RESPONSIBLE FOR THE LOSS OF WHEELS, ANY DAMAGE TO THE TRAILER OR TO ANY THIRD PARTY DAMAGE. DAMAGES MUST BE REPORTED IMMEDIATELY TO TABLEVIEW TRAILERHIRE

4. THE HIRER SHOULD RETURN THE TRAILER TO THE LESSOR AND AGREES TO PAY ANY OUTSTANDING FEES THEREAFTER. DEPOSIT WILL NOT REFUNDED IN CASE OF DAMAGES / ACCIDENTS / LATE RETURNS.

5. IF THE TRAILER IS NOT RETURNED WITHIN 24 HOURS OF THE AGREED DATE, IT WILL BE REPORTED AS STOLEN, CRIMINAL AND CIVIL CLAIM STEPS WILL BE TAKEN AND THE HIRER IS RESPONSIBLE FOR THE COSTS THEREOF.
